WHAT ARE PUBLIC BENEFITS?

Public benefits include financial support, aid benefits and services provided by the government to eligible people who demonstrate needs for medical care, food, housing, disability assistance and other basic necessities.

There are no limits for accepting benefits if you are:

1) US citizen 2) Refugee or 3) Asylum-seeker





SOME PUBLIC BENEFITS AFFECT IMMIGRATION STATUS...

If you have 1) No immigration status 2) Green card or 3) temporary visa...

Public benefits can hurt your immigration status if most of your income comes from government assistance, including:

1) Cash payments from government 2) Living in longterm care facility paid by government

Public Benefits Application

Consider the following steps when applying for public benefits.

DISCOVER

Search for available benefit programs at **BENEFITS.GOV**Fill out the **questionnaire** to discover what you're eligible for.



PREPARE

Gather required documents including:

- Proof of **Identity**
- Proof of Residency
- Proof of Income
- Proof of **Disability**

APPLY

Apply **online, in person, by mail** or **by phone**.



CHECK STATUS

Check online or contact programs by phone to **check status** of application or **ask a question**.



RECEIVE BENEFITS

Obtain benefits. Check eligibility status and reapply annually.
